# How much is the subsidy for the energy storage project in Gothenburg Sweden





#### **Overview**

The government subsidy will cover 60% of the cost of installing a residential energy storage system up to a maximum of 50,000 kroner or \$5,600. How much will the government subsidy cover a residential energy storage system?

The government will subsidize up to 60% of the cost of installing a residential energy storage system, with a maximum subsidy of 50,000 kroner or \$5,600. The announcement follows the country's plans to stop burning fossil fuels to make electricity by the year 2040.

How much does a government subsidy cover a solar system?

The government subsidy covers up to 60% of the cost of installing a residential energy storage system, with a maximum coverage of 50,000 kroner or \$5,600. This includes the cost of the battery, wiring, control systems, smart energy hub, and installation work for homes with rooftop solar systems.

When will Ingrid capacity build a new battery storage facility in Sweden?

As a next step, Ingrid Capacity is about to commence the construction of another 13 new battery storage facilities in Sweden by the end of 2024, with a capacity of 196MW/196MWh, further strengthening the Swedish electricity grid in the SE3 and SE4 price areas.

How many large-scale battery storage facilities are there in Sweden?

This initiative represents the deployment of 14 large-scale battery storage facilities with a total capacity of 211MW/211MWh - a historic investment and milestone in Sweden's transition towards a fossil-free energy system here and now.

How much money did Sweden commit to oil and gas?

By energy type, Sweden committed at least USD 1.45 billion to oil and gas (at least USD 908.03 million to unconditional oil and gas and at least USD 542.89



million to conditional oil and gas). In addition, no public money commitments identified for coal. Further, no public money commitments identified for hydrogen based on fossil fuels.

Does Sweden need more energy?

"Sweden is facing a significantly increased demand for electricity, which must be addressed through a combination of increased fossil-free electricity production, stronger power grids and improved energy storage. It is a great honor to inaugurate the largest energy storage investment in the Nordics, with 211 MW now connected to the power grid.
