# **Polish telecommunication base station inverter grid connection construction regulations**



## Overview

What are the legislative solutions for cable pooling in Poland?

Some legislative solutions, such as amendments to the existing cable pooling regulations, are linked with the Polish National Recovery and Resilience Plan (reform G1.2.2 “Removal of barriers to the integration of renewable energy sources into electricity grids”).

How will Poland's new grid connection agreement affect DSOs & TSOs?

The amendment also introduces a new type of grid connection agreement designed to address the limited capacity of Poland's infrastructure. Under the proposed rules, DSOs and TSOs will be able to offer flexible connection agreements in areas where the grid is currently constrained.

What does uc84 mean for grid connection?

How much does a grid connection cost in PLN?


The fee will depend on the requested connection capacity, PLN 1 per 1 kV indicated in the request, and will be capped at PLN 100,000. The advance payment for the grid connection is going to double to PLN 60 per requested 1 kV of the connection capacity and will be capped at PLN 6,000,000, instead of

the current PLN 3,000,000.

How much does it cost to connect a kilowatt grid?

For each connection request involving a grid with a nominal voltage above 1 kV, applicants will be required to pay 1 PLN per kilowatt of requested connection capacity, with a cap of 100,000 PLN per connection point. This fee must be submitted together with the application, along with proof of payment, otherwise the request will not be processed.
